### **CHAIR'S REMARKS**

No one could have imagined the extent and impact of Covid-19 when it fully hit UK shores in March. Covid-19 has changed the way we work and how we support those accessing Ecas services to ensure everyone is safe in these unsettling times.

As the situation with Covid-19 escalated Ecas had to take in to account the risk it poses to our clients who have underlying health conditions. Therefore, from 16th March all activities (with the exception of the reading and creative writing group which continued via email), in person befriending and face to face meetings within the Young People's Service were suspended. Ecas' Grants fund was also suspended due to a sharp fall in portfolio value and uncertainty regarding future income through dividend pay-outs.

We do have to remember that the virus arrived in the last month of what had been a busy year. A highlight was holding our AGM event in November which showcased the talents and achievements of our service beneficiaries. (See pages 5 and 6). Our Chief Executive, Ally, gave an overview of how **Ecas has been supporting people with a physical disability for over a hundred years** and provided an outline for our new Young People's Service which was launched in January 2020. (See page 7).

Let's hope it's not too long before we get back to some kind of normality.

The success of Ecas is entirely due to the hard work of many people: our volunteers (befrienders, Directors, committee members and those who support activities); our funders (individuals, companies and trusts); the staff; our many partners (public, private and voluntary sectors) and, of course, our clients.

# BEFRIENDING

Before the emergence of Covid-19, both Volunteers and befriendees benefitted from friendship and connection through visits to the befriendee's home or out in the community for a walk or cup of coffee. When in-person befriending was suspended in March, the majority of matches transitioned into befriending via telephone or video call. Befriending Networks, who are the umbrella organisation for guidance and support to befriending projects across the UK, drafted distance befriending guidelines when Covid-19 emerged. These guidelines were adapted by Ecas and issued to volunteers. Feedback since the transition has been positive.

### **FINANCE REPORT**

he summary accounts show headline investment income increased from £179,499 in 2018/19 to £192,519 in the current year. Donations and legacies decreased from £137,828 in 2018/19 to £12,170 in the current year partly due to receiving a substantial legacy of £130,610 in 2018/19. Stock market jitters in March caused by the Covid-19 pandemic in part caused the Ecas portfolio value to decrease by over £838,000 by the end of the financial year.

Fundraising continues to concentrate on the following restricted funds: transport for clients attending activities, computing and swimming.

Ecas could not achieve what it does without the support of the trusts, companies and individuals that make donations, provide gifts or services in kind and help us in so many ways. Ecas is most grateful for your support and hope it can continue.

I would like to thank our investment managers, Adam and Co, our accountants, French Duncan and my fellow committee members for their continuous support. Special thanks are extended to Jeanette Curtis who has retired after 12 years as a committee member.

### ECAS CRITERIA FOR CLIENTS

cas follows the EHRC guideline that: "You are disabled under the Equality Act 2010 if you have a physical or mental impairment that has a 'substantial' and 'long-term' negative effect on your ability to do normal daily activities.

- 'substantial' is more than minor or trivial, e.g. it takes much longer than it usually would to complete a daily task like getting dressed
- 'long-term' means 12 months or more, e.g. a breathing condition that develops as a result of a lung infection."

### However, please remember that Ecas only provides support to people who have a physical disability.

We regret that the following conditions, on their own, do not meet our criteria: psychiatric disorders, learning difficulties, behavioural disorders, developmental delay, Down's syndrome, autism, visual or hearing impairment, cancer, diabetes, epilepsy, HIV and back pain. Potential users will be asked to complete an application appropriate to the service they require. Please visit our website for more information.

Anyone participating in an Ecas Activity is precluded from being matched up with a befriender as part of our Befriending Service. Likewise, anyone currently matched up with an Ecas befriender is precluded from attending Ecas Activities. We are happy to discuss this with potential clients prior to referrals and applications being made, or when there are changes in circumstances.
